

# Project Puppet / Project Signal – Staff Brief

**Prepared for:** Congressional Staff and Members

## Executive Summary

Project Puppet (internal codename *Signal*) is an NSA-led neuroweapons program, coordinated with the CIA, DoD, and U.S. Space Force.

Although described as national security, it is in practice **targeting U.S. citizens indiscriminately**, including civilians, whistleblowers, journalists, and innovators.

Technologies used include:

- Remote Neural Monitoring (RNM)
- Voice-to-Skull (V2K) / synthetic telepathy
- Directed Energy Weapons (DEWs)
- Satellite-based neuroweapons

These programs are used not only for surveillance but also to steal intellectual property, suppress dissent, and experiment on unwilling civilians.

## Case Studies

**Innovator:** Civilian patent-holder targeted during invention filings. Experienced V2K harassment, disorientation, and sudden incapacity. Later defense contracts mirrored his work.

**Whistleblower:** Former contractor subjected to RNM and directed-energy sleep disruption after reporting internal misconduct. Medical scans showed unexplained tissue heating.

**Journalist:** Independent reporter covering NSA surveillance received persistent V2K threats and migraines timed to publication deadlines. Symptoms reduced when outside known coverage areas.

## Scientific Corroboration

- **Microwave auditory effect** (Frey effect): RF pulses can produce sounds perceived directly inside the skull.
- **Havana Syndrome cases**: U.S. personnel abroad sustained brain injuries consistent with pulsed-energy exposures.
- **DARPA “Silent Talk”**: EEG decoding research demonstrates U.S. government interest in synthetic telepathy.
- **Active Denial System**: 95 GHz millimeter-wave system developed by DoD for crowd control proves directed-energy weapons are fielded and operational.

## Historical Precedent

- **MKULTRA, ARTICHOKE, BLUEBIRD** – coercive mind control programs.
- **NSA SHAMROCK & MINARET** – warrantless surveillance of U.S. citizens.
- **ECHELON** – global signals interception confirmed by European Parliament.

These precedents show repeated misuse of classified programs against civilians.

## **Oversight Gaps**

- FISA courts cover communications, not neural data.
- No statutory ban on neuroweapons use against citizens.
- Whistleblower protections are inadequate for classified disclosures.
- Congressional committees are siloed and denied visibility.

## **Legal Violations**

- **Fourth Amendment** – warrantless neural surveillance.
- **First Amendment** – coercion of thought and speech.
- **Fifth & Fourteenth** – deprivation of liberty without due process.
- **Eighth Amendment** – cruel and unusual punishment.
- **International law** – violations of ICCPR and UN Torture Convention.

## **Proposed Congressional Actions**

1. Hold **hearings** in Judiciary, Intelligence, Armed Services, and Oversight.
2. Demand **classified briefings** from NSA, CIA, DoD, DARPA, and Space Force.
3. Direct **Inspectors General** to audit neuroweapons programs.
4. Pass legislation: **Neural Privacy and Neuroweapons Prohibition Act**.
5. Protect **whistleblowers** who disclose neuroweapons abuses.
6. Establish **compensation** mechanisms for civilian victims.

## **Draft Bill – Neural Privacy And Neuroweapons Prohibition Act**

- Ban development, funding, or deployment of neuroweapons against U.S. persons.
- Recognize neural data as protected under the Fourth Amendment.
- Prohibit experimentation without informed consent.
- Mandate IG audit of all neuroweapon programs within one year.
- Expand whistleblower protections with secure reporting channels.
