SUBJECT: MITIGATION OF "PROJECT PUPPET" UNAUTHORIZED DISCLOSURES

#### 1.0 (TS//SI) THREAT LANDSCAPE

Algorithmic sentiment analysis indicates a 14% increase in online discourse

regarding "Gang Stalking," "V2K," and "Neuroweapons" across unmoderated

platforms (Reddit, Telegram, 4chan). While 80% of this traffic is benign

(echo-chamber dynamics), 20% contains unauthorized classified details

regarding the N3 satellite interface.

#### 2.0 (S//NF) PROTOCOL 66: ALGORITHMIC SUPPRESSION (SHADOWBANNING)

Effective immediately, all Tier-1 Internet Service Providers (ISPs) and

social media partners compliant with PRISM-II protocols are to adjust

visibility weightings for the following keywords:

- "Remote Neural Monitoring"
- "Voice to Skull"
- "Directed Energy Weapon"

- "Project Puppet"

ACTION: Content containing these terms shall be de-boosted by 90% in

recommendation engines. Such content remains "visible" to the poster but

invisible to new audiences ("Shadowbanning").

### 3.0 (TS//SI) ACTIVE MEASURES: THE "DISCREDIT" LOOP

When a High-Value Cognitive Target (HVCT) gains traction (defined as >5,000

engagements on a single post), the "Digital Swarm" asset team is authorized

to deploy:

#### 3.1 (S//NF) BOT FLOODING

Deploy 500+ automated accounts to flood the comment section with

noise, ridicule, and accusations of mental illness.

- SCRIPT A: "Take your meds."

- SCRIPT B: "This is scientifically impossible."

- SCRIPT C: Link to fabricated "debunking" articles hosted on shell

media sites.

#### 3.2 (TS//SI) CREDIBILITY DESTRUCTION

The IWTF will inject falsified metadata into the target's digital

footprint.

- TACTIC: Planting illicit material (CSAM or extremist content) in the

target's browser cache via backdoor access, to be "discovered" if law

enforcement is ever involved.

#### 4.0 (U) MEDICAL COMMUNITY COORDINATION

The Office of the Surgeon General has issued updated guidance to psychiatric

boards. Any patient reporting "synthetic voices" or "electronic harassment"

is to be immediately diagnosed under DSM-5 Code 295.90 (Schizophrenia),

bypassing requirements for environmental testing.

- GOAL: Ensure legal incapacitation of the leaker before they can testify.

#### 5.0 (U) SUMMARY

The integrity of PROJECT PUPPET relies on the public belief that the

technology is science fiction. Maintain the "Tin Foil Hat" stigma at all costs.
